RESTRICTIONS ON THE SALE OF CALVES

A calf which is less than 7 days old or which has an unhealed navel, or had been to a market more than twice in the previous 28 days will not be permitted to enter a market. The order requires all calves sold to be removed from the market within 4 hours from the time the last calf was sold by auction. In this context a calf means a bovine animal under 12 weeks of age. NOTE: This is a précis of the more important points covered under the Order. Further information can be obtained from any Animal Health Officer.

This sale is subject to Kivells standard conditions as posted at the market premises and available for inspection at the firms offices Kivells as auctioneers, act as principals in all financial transactions.
